Participation in competition "Gold Medal"- 100 \$ (Acceptance of applications by August 31, 2017)

2. The cost of participation includes:

Rent of exhibition stand or exhibition space
 General advertising of the exhibition-fair
 Making of the inscription on the fascia panel
 General protection of the exhibition-fair at night (from 18.00 to 9.00)
 Cleaning of passages between stands
 General electric lighting of the exhibition-fair

3. Participation in the catalog:

Placement of brief information (up to 50 words) about the Exhibitor in
 The official catalog of the exhibition-fair (format A 5).
 Receipt of information by August 29, 2017.

4. Type of stands:

The minimum area of the standard stand is 4 sq.m,
 Standard stand is offered in the following complete set:
 Wall panels (h = 2.5 m) along the perimeter of the stand,
 1 table and 2 chairs for every 6 sq.m of area,
 2 spot-scoops for every 6 sq.m,
 carpet covering,
 trash can.

5. Registration fee:

 Placement of brief information (up to 50 words) about the Exhibitor in the official catalog of the exhibition-fair

6. Payment for participation:

The Exhibitor makes an advance payment of 100% of the contract amount after it is signed.
 The final settlement is made until September 15, 2017.
 The payment is accepted in soms at the rate of the National Bank of the Kyrgyz Republic on the day the contract-application is concluded.

7. Refusal of participation:

In case of refusal to participate in the exhibition-fair no later than 40 days prior to the beginning of the exhibition-fair, the Exhibitor is refunded the paid amount with the exception of tax collections and the sum of brief information about the exhibitor in the official exhibition catalog. If the Exhibitor refuses to participate in the exhibition-fair in less than 30 days - then the paid amount will not be refunded. Refusal of participation is accepted only in writing, certified by the seal and signature of the manager.

8. Responsibility of the Parts:

The rights of the Participant can not be transferred to another person. The participant has no right to transfer the presented area, and also to sublet it in full or in part without written approval from the CCI of the KR. The participant bears property responsibility for damage (damage) of exhibition equipment and property.
 The participant is responsible for compliance with fire safety, safety and health regulations.
 In case of their violation, the Participant pays all the penalties that are applied by the respective control bodies, and also reimburses the cost of the damage.
 In case of cancellation of the exhibition on the initiative of the Exhibition Organizer, he returns to the Exhibitor the amount received within 5 working days from the date of cancellation of the exhibition. At the same time, the Exhibition Organizer is obliged to immediately notify the Exhibitor in writing about the cancellation of the exhibition.

9. Dispute Resolution Procedure

The Chamber of Commerce and Industry of the Kyrgyz Republic is not responsible for losses, damages or delays caused by natural disasters, war, military actions, revolution, civil actions, prohibitive or restrictive acts of administrative bodies and other force majeure circumstances that impede or disrupt the holding of the exhibition. In this case, the CCI of the Kyrgyz Republic reserves the right to postpone the dates of the exhibition to a later time. The amounts paid by the Chamber of Commerce and Industry of the Kyrgyz Republic connected with the holding of the exhibition-fair are not returned. The Exhibitor shall be released from liability for non-fulfillment and / or improper performance of his obligations under the Contract if proper performance was not possible due to force majeure circumstances, namely: natural disasters, military actions, civil unrest, acts of state bodies. The party affected by force majeure circumstances must notify the other Party in writing of the occurrence of force majeure circumstances, but not later than five calendar days from the date of their occurrence, and also provide official documents (document from the relevant authorized state bodies and / or other competent authorities), Indicating such circumstances.
